FUNDED THROUGH GRANTS DURING THE YEAR, ALA PROPERTY MANAGEMENT AND SOCIAL SERVICES STAFF HAD FREQUENT AND REGULAR COMMUNICATION AND SPECIAL ACTIVITIES REGARDING COVID POLICIES, PROPERTY MANDATES, DISTRIBUTION OF PPE, EQUIPMENT, AND MONTHLY CLEANING SERVICES TO MITIGATE THE THREAT AND KEEP RESIDENTS SAFE. THERE WERE NO REPORTED INCIDENCES ACROSS ALA PROPERTIES.

THE COUNTY BOARD OF SUPERVISORS' AFFORDABLE HOUSING MOTION, CALLED OUT 'SHARED HOUSING' AS A STRATEGY THAT SHOULD BE PART OF THE COUNTY'S OVERALL PLAN TO ADDRESS THE SHORTAGE OF AFFORDABLE HOUSING. 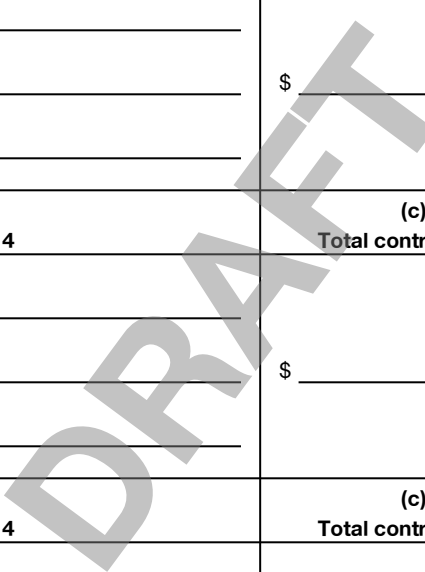

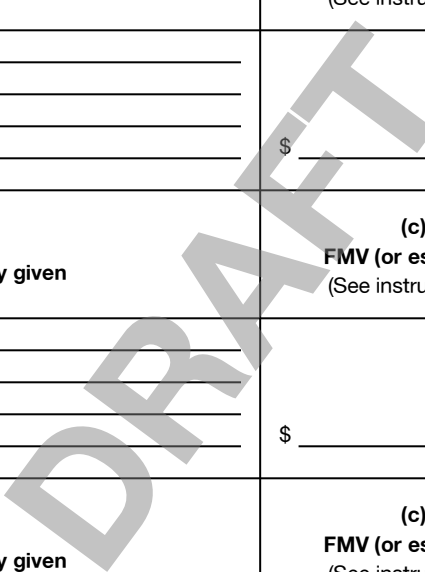
